NOVEMBER - THIS AND THAT BY MARLYN TAYLOR, ARD

Marlyn talked about a study sponsored by valve manufacturer Edwards-Sapien, that showed that over a one year period a Transcatheter Aortic Valve Replacement (TAVR) cost less than a surgically replaced aortic valve (SAVR). That's because of the of the length of the patients stay in CCU and in the hospital as well as the use of skilled nursing facilities for SAVR patients.

Marlyn then talked about the health of Mended Hearts of Southern Oregon and the need of members to step up and help as officers and chairs.

Marlyn then covered atherosclerosis which is the build up of plaque in ones arteries. Atherosclerosis is a leading cause of death in the US. Marlyn covered what is, the dangers, what the risk factors are and how to avoid being a victim.

I guess people waited and then decided to get things taken care of before their insurance 'reset' in January. It made for a very busy hospital and started a new process for TAVR patients.

TAVR patients were being admitted on the Wednesday afternoon prior to their Thursday procedure. Because the Heart Center and CCU were full some TAVR patients were sent home and asked to come in on Thursday to be admitted before their procedure.


My understanding is that, going forward, the TAVR patient who is first on Thursday will be admitted on Wednesday and the others will be admitted on Thursday. That changes how our TAVR visitor will connect with patients prior to their procedure and will mean that our regular visitors will need to talk to the patients on Friday after their procedure to give them a HeartGuide and Cardiac Rehab contact list.

It's been a very successful year and we continue to do great support work at ARRMC as well as support for our members and others who come to our meetings. We look forward to continuing to provide support to heart patients and their caregivers. We also hope to expand the kind of heart patients we are able to support.

TRANSCATHER MITRAL VALVE REPLACEMENT IN FEBRUARY



We're told that the first Transcatheter Mitral Valve Replacement (TMVR) procedure will be performed at Rogue Regional in February. That's 4 years after ARRMC's first TAVR in February, 2015.

We hope to have a cardiologist come and talk to us about this new procedures in March.

LOW-RISK TAVR IS ANTICIPATED IN 2019

Two trials may result in the FDA approval of Transcatheter Aortic Valve Replacement (TAVR) for low-risk patients. Currently, one must be a high or intermediate risk patient to be a candidate for a TAVR. The process currently involves having the patient jump through a lot of hoops to be approved for a TAVR.

PARTNER 3 and CoreValve Low Risk are the two trials that will provide short-term results for low-risk patients soon. The trials are for low-risk patients who got either the Edwards Lifesciences Sapien 3 valve or the Evolut R valve from Medtronic for severe aortic stenosis. PARTNER 3 involved the Edwards valve and Corevalve Low Risk the Medtronics valve.

The expectation is that the results of these trials will be presented in March to the American College of Cardiology. If the results prove positive, the FDA is likely to grant commercial approval for low-risk patients. Then TAVRs will then be the primary procedure for replacing stenotic aortic valves. That

will be terrific for recover and lifestyle...a new valve without opening the patient's chest.

If TAVRs are approved for low-risk patients, they will be the predominate way aortic valves are replaced. Although most will, no doubt, opt for the TAVR where it is appropriate, younger patients may opt for a mechanical valve that will last longer. Time will tell.

IS A TAVR OR SAVR BETTER IF YOU HAVE AORTIC VALVE DISEASE?

How do you make the best decision for treatment if you are diagnosed with aortic valve disease. Will it be a Transcatheter aortic valve replacement (TAVR) or a surgically replaced aortic valve replacement? A shared decision that you feel confident in is vital. How do you make that decision?

Recently Mended Hearts hosted an important webinar titled, "Shared Decision Making in the Era of Evolving Treatment Options for Aortic Valve Disease". In the era of advancing treatment options for valve disease, it is vital that patients understand how true shared decision making can be achieved. Shared decision making is more than just patient education. It's about feeling confident in the decisions you make about your care. Ask yourself if you feel confident in your understanding of valve disease? Do you feel sure that your doctor understands your concerns and desires?

CAN CINNAMON HELP CONTROL BLOOD SUGAR?

Researchers are studying the spice cinnamon to see if it helps control blood sugar, as folk treatments suggest. Researchers stress findings are not conclusive since other factors, such as exercise, cinnamon quality, and adherence to medications were often not accounted for. The researchers concluded that the spice deserved more research, but stressed that there is no evidence that cinnamon alone can control type 2 diabetes. Diabetes medications are essential.

The review was published in the Journal of the Academy of Nutrition and Dietetics
